- (B) All personal information provided via this Agreement shall be deemed to be and shall remain the property of the EFS, and shall not be disclosed to any third party without prior consent of the athlete unless required under any legislation in force at the time of disclosure.
- (C) Athletes must abide by the terms and conditions as listed and conditions will result in immediate disqualification from the scheme and further assistance under the athlete support schemes and services.
- (i) Maintain regular attendance at training and follow an adequately comprehensive regime of training throughout the year satisfactory to the EFS and
 - (ii) Maintain / improve performance level satisfactory to EFS.

- (iii) Be of good conduct at all times.
- (iv) Shall not commit any criminal offence.
- (v) Shall comply with the International Olympic Council (IOC) Medical Code (deemed as incorporated into these terms and conditions), and as such will not be involved :
 - (a) with the use of, counselling of the use of, permitting the use of or condoning the use of any banned substance;
 - (b) with prohibited methods (blood doping, pharmacological, chemical and physical manipulation) and prohibited substances which should not be used by any athlete.
- (vi) Shall return all HPM support and assistance scheme grants in the event he/she stops training without valid reasons, or suspension by EFS.
- (vii) Fulfil his/her obligations to appear at events as and when agreed to with the EFS.
